Pursuant to Idaho Code §34-1405, NOTICE IS HEREBY GIVEN for the candidate filing deadline for the following taxing districts that will be conducting candidate elections in Cassia County on Tuesday, November 5, 2019. In order to appear on the Consolidated Elections ballot, a candidate must file a Declaration of Candidacy form no later than Friday, September 6, 2019, with the office of said districts, as stated below. Individuals who run as write-in candidates must file a Declaration of Intent no later than 5:00 p.m. on Monday, September 23, 2019, pursuant to Idaho Code 34-1407.
