

**OAKLEY RECREATION DISTRICT
NOTICE OF SPECIAL ELECTION
NOVEMBER 6, 2018**

NOTICE IS HEREBY GIVEN that, pursuant to Resolution No. 2018-001 adopted by the Oakley Recreation District on February 7, 2018, a special election will be held in the Oakley Recreation District on Tuesday, November 6, 2018, between the hours of 8:00 a.m. and 8:00 p.m. for the purpose of voting upon the question and proposition of increasing the levy on the taxable property with the Oakley Recreation District by the amount necessary to produce the sum of eighty-six thousand nine hundred seventy-two dollars and seventeen cents (\$86,972.17) per year (for an effective District levy rate of 0.0006) beginning with the tax year 2019, to provide additional funding for the Oakley Recreation District as provided in Resolution No. 2018-001 of the Oakley Recreation District adopted on the 7th day of February, 2018.

The Oakley Recreation District has adopted the following Official Statement: On November 6, 2018, a special election will be held on the question of a levy to provide additional funding for the Oakley Recreation District as provided in Resolution No. 2018-001 of the Oakley Recreation District adopted on the 7th day of February, 2018. The levy will be assessed per year beginning with the tax year 2019, and it is estimated that eighty-six thousand nine hundred seventy-two dollars and seventeen cents (\$86,972.17) per year (for an effective District levy rate of 0.0006) will be collected each year.

The question to be submitted to the electors of the Oakley Recreation District shall be by ballot reading substantially as follows: Shall the Board of Directors of the Oakley Recreation District be authorized to levy a permanent override levy in the amount of \$86,972.17 (for an effective District levy rate of 0.0006) per year commencing with the fiscal year beginning 2019, for the purpose of paying all lawful expenses as provided in the resolution of the Board of Directors of the Oakley Recreation District adopted on February 7, 2018?

NOTICE IS FURTHER GIVEN that in accordance with the Help America Vote Act of 2002, each of the polling places includes parking spaces, path of travel, entrances, exits and voting areas accessible to individuals with disabilities. Qualified electors shall vote at precinct polling stations as designated below by Cassia County.
